WHEREAS the Municipal Commissioner for Municipal Corporation of Greater Mumbai has
interalia delegated under Section 68 of the Mumbai Municipal Corporation Act, his powers, functions
and duties under the provisions contained in chapter III of the Mumbai Municipal Corporation Act to
the Dean / Director (M.E. & M.H.)

AND WHEREAS the student has applied for admission for the M. B. B. S. / B. D. S. degree
course (hereinafter referred to as "the said course") in
College at
(hereinafter referred to as "the said College") of the Corporation.

AND WHEREAS the Corporation has agreed to admit the said student for the said course
in the said college on the terms and conditions hereinafter appearing :-

NOW THESE PRESENTS WITNESSES AND IT IS HEREBY AGREED BY AND BETWEEN
THE PARTIES AS FOLLOWS :-

1. The Corporation shall admit the said student in the said college for the said course from the
academic year
2. The student shall diligently prosecute and complete the said course at the said college or any
other Medical college within the limits of Greater Mumbai and strictly comply with the rules
and regulations of the said college as aforesaid.
3. The student shall during the said course maintain good conduct and character, attend the
college regularly, complete the said course and thereafter duly pass the prescribed University
Examination for the said course.

only) or such lesser sum as the Corporation in their absolute discretion may decide as liquidated damages and the said amount shall become payable by the said student on demand to the Corporation.

- 10. The student shall on passing the University Examination and after undergoing Internship training as aforesaid and obtaining his/her M. B. B. S. / B. D. S. degree shall not go abroad within a period of 5 years and in such event he / she shall reimburse an amount of Rs. (Rupees only) towards the expenditure incurred by the Corporation on his/her Education in addition to the liquidated damages as per Condition No. 9 above. Provided that where the student is desirous of continuing the post-graduate studies and if the Corporation in their absolute discretion grants to the students to do so, decision of the Corporation in that behalf shall be final and binding on the student, and the aforesaid provisions contained herein shall become applicable on the students passing such Post-Graduate examination.
- 11. Any dispute arising out of this agreement shall be subject to Mumbai Jurisdiction only.
