

BOND FOR MBBS COURSE: DULY ATTESTED BY NOTARY PUBLIC SURETY

1. In pursuance of my undertaking given on (dated) the Surety Bond, herein aftercalled the Bond, is executed at Delhi on this (date) day of (Month) 2023 by Mr./Ms.---(Name of the Candidate)--- S/O/D/o ---(Name of Father)--- hereinafter called the student, admitted in MBBS Course, hereafter the course, at University College of Medical Sciences, Delhi hereafter the college, in favour of the Registrar, University of Delhi and the Principal of UCMS, Delhi.
2. Whereas the student has applied and has been admitted in MBBS course, an Under- Graduate Para-Medical Course, being conducted by the University of Delhi.
3. Whereas on the basis of the merit, the student was offered MBBS course available at the time of his/her counselling and he/she has been admitted in the course at the College/Institution with the understanding and subject to the undertaking that the student shall undergo the course on full time and regular basis and shall maintain the required standard of performance and shall not indulge any act of indiscipline / misconduct.
4. The student has, therefore, agreed to be liable and bound to pay a sum of **Rs.3,00,000/- only (Rupees Three Lakh Only)** to the college/institution, in the following circumstances.
 - A. **If a student surrenders seat in violation of MCC rules/instructions, after joining the allotted Institute.**
 - B. **If a student does not join the course at the allotted institution after allotment of seat in the Stray Round counselling.**
 - C. **If the student leaves the courses before its completion.**
 - D. **If the admission/registration of the student is cancelled/terminated by the University/College on account of unsatisfactory performance/misconduct/indiscipline etc.**
5. Whereas the student undertakes that till the entire SURETY amount **Rs.3,00,000/- only (Rupees Three Lakh Only)** is paid, the College/Institution/ or the University of Delhi shall have the right retain all original certificates submitted by the student at the time of admission and thereafter and also refuse to issue any certificate with regard to the course of study or dealings as a student.
